Call to Order/Pledge

**I. Call to Order of Public Hearing/Pledge-President Gallagher**

President Gallagher called the meeting/public hearing to order at 7:35 PM and led the community in the Pledge of Allegiance.

Superintendent Weiss and the Board of Education Members addressed some questions involving potential election process violations with the public.

- Superintendent Weiss congratulated Dr. Ryan on his re-election and Mrs. Vrona on her election. Thanked everybody who participated in the electoral process and to the community for supporting the school budget. There was a use of school time, PTA time for electioneering. There was a use of school email communications to advocate for both the budget and individual candidates. There was the display of information related to partisan activities which is not permitted.
- Vice President Ryan explained that school board candidates are volunteers who serve the children and indirectly adults and families. He noted that the actions of the teachers union president in sending a letter to retirees which claimed that their health benefits would go up as much as \$1,000 per month was irresponsible and claimed that the election was tainted as a result. Appropriate actions were to be taken to prevent this from ever happening again.

- Board Member Lester addressed the issue that people do not get involved in running for office because it is too dirty. But historically, school board elections have been devoid of dirty politics. This election descended to a low level.
- Board Member Tangney agreed with the other board members and did not see the need for it. She questioned whether all of the executive board members were aware of the letter to the retirees.
- Board Member Mininsky thought it casted a shadow over the election. He received numerous phone calls from retirees. Thought it was unfortunate.
- President Gallagher stated that it is the goal in Long Beach not to have tainted elections.
