Report of the Superintendent

II. Report of the Superintendent – David Weiss

- Mr. Weiss thanked everyone for their support of the school budget and congratulated Mrs. Tangney and Mr. Mininsky on their re-election to the Board. Thanked all participants in the parade.

- **Presentation – Food Service Update – Steven Kamlet**

Highlights include: Profit and Loss, Participation Data, Staffing, Review of 2014-15 New Food Items, Highlights from the Food Services Advisory Committee. Joanne Rea noted that the committee was brainstorming to bridge the budget gap. Ideas include: visiting communities, growing vegetables, building greenhouses, beautifying the cafeterias, encouraging lunch periods for HS students. Presentation can be found on-line on our website and in the office of the District Clerk.

III. Board of Education Comments

Board of Education Comments
--

- Board Member Ryan thanked the public for coming out to the Memorial Day parade; suggested shorter waiting time for the students (Mr. Weiss is discussing with the city); was displeased with the lack of knowledge of Board Member names by City Council members.
- Board Member Lester believes students should have to take a lunch period. (Mr. Stroud agrees – 400 of 1300 students have no lunch period).
- Dr. Ryan suggested that the Wellness Committee take that up; teachers allow students to eat in class; students need down-time; suggested breakfast offering (limited – looking into broadening for next year); asked about profits from vending machines (\$800 - \$1200 per month); encouraged staff to purchase lunches.
- Mr. Lester asked about pre-payments on line (yes); breakfast times (1st period – grab and go).
- Board Member Vrona asked when the last price increase was (2014); questioned the projection of better numbers for next year; when were new items introduced (February 2015); questioned breakfast at MS; cost for bringing up pizza ovens (\$10-11K)
- Vice President Mininsky commented that if they do not like the new healthier ingredients, it does not matter where the pizza ovens are; asked when the district would be self-sufficient as required by law (never)
- Ms. Vrona noted that Oceanside is close to break-even despite being an open campus.

Board of Ed Comments on Presentation

- Board Member Lester asked about investigating the public bus (already doing it but not free).
- Board Member Ryan supports transition to Transfinder; voiced concerns about safety of city buses with no flashing lights; will bring up policy revisions at Policy Review Committee meeting; unintended consequences with transportation suggestions.
- Vice President Mininsky asked about projected cost savings.
- Board Member Vrona thanked the committee on a great presentation; Transfinder a no-brainer.

V. Vice President Mininsky called for Questions and Comments from the Public – Items on Tonight’s Agenda Only

Questions and Comments from the Public

- Joanne Rea – 90 Connecticut Ave – we need afterschool buses for schools of excellence; city bus too dangerous for young students; BAC should have looked at parochial schools; safety first; fights on buses; suggested trial basis for Transfinder; suggestions won’t save much money.
- Kate McDonough – W. Chester St – schools of choice won’t matter about distance; private school use city buses; public will have to pay not private school students.
- Sonia Brown – 67 Curley Street – mother of MS and HS student, PT Accounting Clerk for Food Services, member of committee, supports moving ovens up; kids want fresh pizza on Friday; pizza unappealing; creativity breeds new business; if we don’t change, food services will die.
- Gerri Maquet – 523 E. State St – thanked FSA Committee and BAC for their presentations; asked if waste had improved and how it was being monitored; HS breakfast only 30 kids participate; concerned about 6th graders taking city bus; more appropriate at HS level; should be no charge for city bus passes; people do not stop for buses and children crossing the street.
- Rebecca Kittrell – 94 Ohio Avenue – noted that taking a bus is better (safer) than walking and/or biking; safety is on all of our minds.
- Gregory Naham – 355 Blackheath Road – wanted the public to know that public bus would bypass terminal .
