Members of the Public

I. Superintendent's Opening Remarks/Call to Order

Board President Conway called the regular meeting of the Board of Education to order at 7:03 pm and led the public in the Pledge of Allegiance. Mrs. Conway welcomed everyone back from the spring break vacation. Wonderful to see a packed house tonight.

II. Superintendent's Report - Dr. Gallagher

Superintendent's Report

- Student Showcase: Surf for All Program
- 2023-2024 Budget Presentation Budget Adoption

Dr. Gallagher said she was excited to introduce a relatively new program in the district that has grown over the past few years and one of our biggest points of pride. She then introduced Dr. Ostroff, who thanked all who make the program possible, including Board, administrators, students, the athletic department, and high school and PPS staff. Students are able to practice patience and balance, courage and joy in a sport that is unique and special to our community. Dr. Ostroff showed a video highlight of the program; the Board presented Surf for All participants with certificates; Kiashaw Felder, a participant in Surf for All, spoke about his experience in the program.

Board President Conway expressed regrets on behalf of Board Member Vrona, who could not be in attendance due to a prior family commitment.

Mr. DeVito then presented the "Final Draft Budget and Revenue Projection", stating that the 2023-24 Proposed Budget does not include funding for capital projects the there is a proposal to spend \$5.2 million from the district's capital reserve to fund work at the high school, middle school and Lindell Elementary; there is about \$4 million in additional operating costs; \$1.2 million of additional (increase) in State Aid, LIPA Pilot remains the same, additional revenue through interest of \$1.3 million, increase in tuition from students transferring in from Island Park. This has allowed us to keep the tax levy at a low 1.5%. Mr. DeVito reiterated that the increase in program costs at the elementary, middle and high schools are largely due to contractual salary increases. Transportation increases are due to the addition of three new routes based on additional students and schools, contract transportation costs increased due to additional students traveling to existing and new out of district schools, and bus monitor cost increases. Facilities increase largely due to increase in natural gas heating and electricity costs. Mr. DeVito reiterated to the public that we are requesting to ask the public for permission to use \$5.2 million in the capital reserve fund to complete certain capital projects. Since we are using funds already on hand, this will have no impact on the budget or tax levy.

The "Final Budget and Revenue Projection" presentation is on the District Website and available in the office of the District Clerk.

III. President Conway called for Board of Education Comments

BOE Comments

- Board Member Ryan thanked Mr. DeVito, stating that a 1.5% tax levy is a pretty responsible number; district has done its best to preserve program, and particularly grateful for that. Dr. Ryan asked how much of the "Biden Money" (ARP Grant) will be left to spend next year, and Mr. DeVito replied approximately \$1 million. Dr. Ryan asked about electricity increases is that about a million dollars? (Yes). He also asked if Science Research is continuing (yes). He asked if the district has sufficient coverage for cyber insurance, and Mr. DeVito replied yes, we consult with experts and is confident we are well protected. Dr. Ryan stated to the public, that he would like all to know that we are a very responsible group here, and is proud of the 1.5% tax levy.
- Board Member Pace asked Mr. DeVito to share what can be publicly shared regarding measures the district has in place for security, and Mr. DeVito stated that we do have a District Safety Plan published on the district website, and there are building level emergency plans in place that are kept confidential, we have drills, we have a specialist from BOCES that reviews the plans. We also have regular meetings with law enforcement. He added that when experts do come in, they commend us on what we have in place in terms of security. Ms. Pace then asked, regarding capital projects, what happens if that is not approved, where does that money go? Mr. DeVito said that then the money "just stays there", as it can only be used for capital projects.
- Board Vice President Pinto asked if doing a 1.5% in the tax levy, does that impact everyone, and Mr. DeVito replied that everyone who is a property owner has a share in that levy; how each homeowner is assessed is based on dwelling classification, which varies based on assessment that comes from the County. Mr. DeVito stated that we are very grateful that the State has awarded the district approximately \$2 million for full day Pre-K at all four elementary schools.

- Board President Conway asked about the slight reduction in AIS in math at the Middle School, and Mr. DeVito replied that it was enrollment-based. Ms. Conway asked if we have enough bus drivers, and Mr. DeVito replied that we are almost there, we have the most we have had and are looking to hire 1 2 more. Ms. Conway asked about the recent fire alarms, do we know when that work will start or when it will be completed, and Mr. DeVito replied that he does not know yet what the specific scope of work is; difficult time finding a vendor we feel comfortable with, at the very least, we want to replace the fire panels.

and safety of District students, staff and others present in the affected District buildings and constitutes such immediate action which cannot await competitive bidding or competitive offering; and

WHEREAS, on January 10, 2023, the Board of Education of the Long Beach City School District approved a resolution to declare the timely and immediate procurement of plumbing services at the Long Beach High School as referred to above to be essential to protect the life, health and safety of District students, staff and residents; to constitute action which could not await competitive bidding or competitive offering, pursuant to General Municipal Law Section 103(4); and to authorizes the engagement of Seaford Avenue Corporation as referred to above for a sum of not to exceed \$30,000 without competitive bidding or competitive offering; and

WHEREAS, there was an unexpected cost increase in the plumbing services by Seaford Avenue Corporation to remedy the emergency at the Long Beach High School which necessitates a modification of the January 10, 2023 resolution.

NOW, THEREFORE, BE IT RESOLVED, that upon the recommendation of the Superintendent of Schools, the Board of Education of the Long Beach City School District hereby declares the timely and immediate procurement of plumbing services at the Long Beach High School as referred to above to be essential to protect the life, health and safety of District students, staff and residents and to constitute action which could not await competitive bidding or competitive offering, pursuant to General Municipal Law Section 103(4); and hereby authorizes the engagement of Seaford Avenue Corporation as referred to above for a sum of not to exceed \$65,000 without competitive bidding or competitive offering.
