## II. APPOINTMENT OF THE SUPERINDENT OF SCHOOLS

#### Appointment of Superintendent of Schools

President Ryan detailed the process used for hiring the new Superintendent, after Dr. Greenberg announced his resignation for purposes of retirement in January 2011. The Board of Education chose to recruit for a new Superintendent by itself rather than spend District funds. Mrs. Butler helped to coordinate the search details which included: the review of 20 applicants, a diversified screening committee with both school and community members, an Administrative Council committee and multiple Board interviews. Mr. David Weiss was selected. Glowing references and résumé highlights were read by Dr. Ryan.

Mr. David Weiss – congratulated OM students, staff and parents; thanked Dr. Ryan, Dr. Greenberg, screening committees, and his family for this opportunity; credited Dr. Greenberg and Board with revitalizing the schools. He will work with Dr. Greenberg, administrators and members of the school community to gather information, bringing fresh eyes to discussions. We want to look with pride at our schools and at the opportunity we create for our students to excel.

**BE IT RESOLVED**, that the President of the Board of Education is hereby authorized to execute the employment agreement dated May 10, 2011, between the Long Beach City School District and David Weiss, which appoints Mr. Weiss as Superintendent of Schools of the Long Beach City School District effective July 1, 2011.

#### III. Superintendent's Report – Dr. Greenberg

Dr. Greenberg welcomed David Weiss and felt confident about a seamless transition; heard similar words of praise about Mr. Weiss when he left Rockville Centre; finalized sales of bonds; received favorable rate with Morgan Stanley; discussed MS controversy regarding grouping including interviews with CNN.

Mr. Kenneth Graham announced science award winners. ISWEEP Competition – Houston, Texas – all 3 earned awards.

Mr. DeVito explained the details of the bidding process for the bonds; accepted Morgan Stanley offer 3.318% interest rate.

#### Middle School Update Presentation- Dr. Vincent Butera

Dr. Butera presented MS Update, included Adelphi Poetry contest awards, Odyssey of the Mind awards, Simons Research Program, Locust Valley Film Festival Award Winners, Navy Seal Challenge, ISWEEEP (science awards) winners; Systematic Improvements, graduation rates, 8<sup>th</sup> grade math exam passing rates, Quality of Instruction, Curriculum, Instruction, Differentiated Continuum, Assessments, Professional Development, Heterogeneous/Homogeneous Grouping, 8<sup>th</sup> grade Earth Science. Presentation is on-line and filed with the District Clerk.

Dr. Greenberg reiterated that the District was leveling up the field, not dumbing it down. He encouraged Board to continue in this direction to better prepare all students for the future, but would suggest the decision be left to the new superintendent. While he saw the bond sale, the reorganization of administration/directors and the beginning of IB, he suggested that Mr. Weiss, the Board and the community would be doing a disservice to a large number of students if the district does not move in this direction.

# IV. President Ryan called for Board of Education Comments

**Board of Education Comments** 

- Vice President Gallagher discussed the need for rigor in our schools for all students; suggested an October meeting with the community regarding important issues; requested a demographics study; and supported a one year moratorium on the 7<sup>th</sup> grade issue.
- Board Member Tangney agreed with Mr. Gallagher and Dr. Greenberg, but insisted on a proper assessment of the effectiveness of the program, challenge for all.
- Board Member Guma appreciates the dialog/concerns with parents; inspired by Condoleeza Rice - school district needs to challenge students, raise expectation, encourage the arts, and insist on harder tasks outside of the comfort zone. Let new administrators analyze situation. It is not where you come from; it is where you are going that makes the difference.
- President Ryan attended parent meeting; thanked Dr. Butera. He discussed that every classroom is heterogeneous due to the range of abilities of students; it is all just semantics. Issue of curriculum, sequence, developing classes, IB teaches new skills, use engagement, learning, and homework. It cannot go on as is. Board wants to talk about education, to look and reflect, long term, and change and adapt.


