Members of the public may address the Board of Education on any specific agenda item during special times reserved for that purpose prior to Board discussion and action. Worksessions provide opportunities for the Board to deal with specific educational and other operational matters critical to the effective running of District, in order to provide the Board with the information they need to set school district policy. Visitors are invited to submit questions pertaining to the worksession topic after the worksession presentation and Board discussion are complete. On occasion, the Board may include specific action items on the agenda prior to the start of the worksession or after the worksession business is concluded.

Visitors who wish to address the Board on matters other than those pertaining to the evening's worksession topic are asked to defer their comments until the next regular Board business meeting.
