- Board Member Mininsky asked if FEMA was picking up the total costs (currently FEMA 75% - state and local share – expecting 90%)
- Board Member Gallagher asked about bond projects and brick wall.

- Vice President Tangney asked about the 2<sup>nd</sup> floor ceilings and dropped ceilings, windows being compromised (pre-existing condition), kitchen, cafeteria and asked that cafeteria be included in presentation; questioned use of fund raising monies (first floor).

- Vice President Tangney requested the completion date for the gym (June 6), moving up ceremony indoors or outdoors; playground equipment undamaged; surface materials washed away; community center responsibility (repairs are theirs; filing jointly); asked about the library (repairs belong to city)
- Board Member Gallagher noted that the original agreement noted their responsibility (we own the land).

**WHEREAS**, Web Construction was the lowest responsible bidder for the bid for the general construction;

THEREFORE BE IT RESOLVED, that upon the recommendation of the Superintendent of Schools, the Board of Education hereby determines that Web Construction was the lowest responsible bidder for the bid for the general construction and approves the award of bid for general construction to Web Construction.

### B) AWARD OF BID FOR PLUMBING WORK TO MACCARONE PLUMBING, INC. (Contract #1-W-DWSR -2)

**WHEREAS**, Maccarone Plumbing, Inc. was the lowest responsible bidder for the bid for the plumbing work;
