**III. President Lester called for Board of Education Comments**

Board of Education Comments

- Board Member Vrona asked if the numbers were different from last week's presentation (ye – staffing vs. consultant costs, rollover); were the special ed issues remedied, corrected, new referrals (yes – added services, increase in referrals is main driver of numbers, out of district up 14% in student costs); isn't it really 28% - 14% plus 14% (yes); do out-of-district expenses include impartial hearing settlements (no – they are listed under a separate code).
- President Lester asked if contractual codes are \$7.7 million (yes); disheartened that costs have risen so much with a capped budget.
- Mrs. Vrona asked if there were more referrals due to Common Core (not the reason; trauma from Superstorm Sandy, lost grant for those services, kids are still distressed and academic demands, learning has changed because of technology).
- Mr. Lester asked about the .4% of 1% tax cap; statewide .12; this alone is double the cap (yes).

- Ms. Jill Butensky – 38 Fairway Road – asked about the number of students being serviced in private shools (32) and about how many students do we service that are not ours (HALB – 30 residents, 100 students/4 teachers, LBCS – 38); what percentage of our students are special ed (14%)
